The grant will assist patients with blood related cancers and their families with patient care support. We also provided patient luncheons and gift bags with such items as gas cards and convenience items. In addition, scholarships were given to students at Adamsville High School, as selected by their scholarship committee. These students' lives were affected by family members with cancer.

Part of our mission is to support other non-profits whose animal welfare programs align with Lisa Ross Parker's legacy. Dogs Deserve Better received a grant of \$1,000 to assist with their programs with chained and penned animals. Paul's Clinic received a \$1,000 grant. This McMinnville, TN nonprofit is making a difference in reducing animal overpopulation with spay/neuter services. A \$750 grant was made to People for Animals to support their mission and reduce unwanted puppies and kittens and reduce the number of healthy animals being euthanized. A \$5,000 grant to Pet Community Center provided a "free vaccine day" for pets in zip codes who have high surrender rates to animal control. In addition to providing the grant, we collected and purchased food and supplies for pet owners at the event. This
