We provided massages for cancer patients, gift bags for their families that included such things as phone and gas cards, and meals for patients and families. This year we were able to purchase a commercial blanket warmer for Vanderbilt Hospital. Patients receiving chemotherapy often become very cold during their treatments. The commercial blanket warmer provides a constant source of warm blankets for patients to ease their discomfort. We used the profits from our Music City Mardi Gras event to pay for this piece of equipment.
