Grants were provided to patients suffering from blood related cancers. These grants were awarded to individuals who were unemployed or otherwise economically disadvantaged. The annual scholarship to Adamsville High School was made to a student who was had a family member suffering from cancer.

4b (Code:) (Expenses \$ 9824. including grants of \$) (Revenue \$)
Assistance was provided to hospital patients and family members at the Myelosuppression Unit at Vanderbilt Hospital, Nashville, Tennessee. Lisa Ross Parker was a patient at this particular wing. Because many patients and families do not live in the greater Nashville area, we provided them with gas and phone cards. Patients usually stay 4-6 weeks at a time with family members at their sides. Refrigerators and microwaves were purchased for patient rooms to provide them access to meals and refreshments they could enjoy immediately with a great deal of convenience.

We also provided chair massages for patients and their families, served lunch for staff and patients' families, and collected and donated books and magazines for the family room. All goods and services were provided on a volunteer basis at no charge to the patients or their families and at no cost to our foundation. Our foundation's goal of providing assistance to patients and families affected by blood-related cancers is acheived by these goods and services.
